1. Introduction

This Request for Proposal (RFP) is issued to provide the selection process for research services, to include data manipulation, upload of data to web-based interactive system, and the preparation of a summary report on project results. Proposals will be accepted from:

- a. Individuals operating as independent contractors.
- b. Non-profit, non-governmental entities,
- c. For-profit, private companies,
- d. Preference is given to academic institutions with experience in water quality research.

Proposers submitting a response to the RFP will be asked at a minimum to state qualifications, understanding/experience relating to similar projects, and offer methodology for meeting the objectives of project criteria.

Note: The total amount available under this RFP will not exceed Eight Thousand Five Hundred Dollars (\$8,500) for contract covering approximately three months of work effort.

2. Purpose and Description of Services

The <u>Citizen Lake Awareness and Monitoring (CLAM) program</u>, sponsored by the Ohio Lake Management Society (OLMS), provides an opportunity for Ohio citizens to take an active role in learning about aquatic ecology, water quality, and watershed management. CLAM documents lake water quality conditions throughout Ohio.

Historical CLAM water quality data since 1989 are currently housed in Microsoft Access, encompassing about 17,000 unique records. Project objectives include, 1) organize database for compatibility with the <u>Water Quality Portal</u>, 2) upload data to the WQ Portal for archiving, and 3) prepare a five-year trend analysis report (for example - <u>2015 report</u>) on the lakes in the Muskingum River Watershed under guidance from program partners.
